- To appear in legal proceedings on behalf of the University
- To file appeals against orders/decrees for and against the IUB in Appellate Courts
- To vet and assist in legal issues pertaining to execution of contracts/agreements
- To obtain necessary comments and documents from the concerned departments/branches
 of the University
- To assist and attend the University authorities at any legal/administrative forum if so required by the Vice-Chancellor
- Any other special cases assigned by the Competent Authority

TERMS & CONDITIONS:

- The appointment of Legal Advisor(s) shall be made on contract basis at fixed monthly remuneration
- The Legal Counsel(s) shall be appointed on case to case basis on such terms and fees as may be fixed by the Vice-Chancellor.
- Preference will be given to the candidate(s) who has/have rich experience of dealing with the cases of Universities and well versed with the University Act, Statutes, Policies, Rules & Regulations, etc.
- The Legal Advisor shall initially be appointed by the IUB Syndicate for a contract period of one (01) year, which may be extended (on yearly basis) up to five (05) years based on satisfactory performance.
- A committee constituted by the Vice-Chancellor shall assess/recommend the panel of candidates on the basis of required professional credentials of the candidates.
